DC Public Charter School Assignments

The School Assignment List identifies the designated Vocational Rehabilitation (VR) support for students based on age and service type. Two categories of assignments are used:

Students aged 17 and older who are receiving **Vocational Rehabilitation Services** are assigned to the Vocational Rehabilitation Counselor linked to their school. These counselors provide individualized VR services and support students as they prepare for post-school employment and training.

Students aged 14 to 16 who are receiving **Pre-Employment Transition Services (Pre-ETS)** only are assigned to the Transition Specialist serving their school. Transition Specialists focus on early career exploration and skill development to help younger students begin planning for future employment.
