RE:	Living Wage Increase Effective January 1, 2022 <i>(revision)</i> and Skilled Nursing Service Rate Changes Effective October 1, 2021

The Department on Disability Services (DDS), Developmental Disabilities Administration (DDA), releases this transmittal to provide a revision to the previously published January 4, 2022 transmittal regarding the living wage increase effective January 1, 2022, and to inform providers of the October 1, 2021 retroactive change to the skilled nursing services rate and temporarily enhanced reimbursement rates for skilled nursing services.

The Department of Employment Services (DOES) living wage increased from \$15.20 per hour to \$15.50 per hour for all workers based on the Consumer Price Index (CPI) as of December 31, 2021. DSP wages shall be based upon the new rate effective January 1, 2022. The corrected enhanced Appendix K rates and procedure codes below serve as a guide for providers to appropriately submit billing claims.

DDS will not publish retainer payment rates in this transmittal as the retainer payment service period ended December 31, 2021. Also please note, Companion Service at a 1:2 ratio was implemented only during the PHE. This 1:2 companion service will end 6 months after the PHE. However, Companion 1:1 and 1:3 services will continue to be available after the federal PHE ends at the standard rate.

The Department of Health Care Finance (DHCF) has also made changes to the skilled nursing service rates with dates of service beginning October 1, 2021. The enhanced Appendix K skilled nursing rates embedded in DDS per diem rates will continue through September 30, 2022, but no longer be in effect at an enhanced rate after this date.

Providers who have submitted claims using the superseded rate schedule can resubmit the claims as adjustments using the new fee schedule for reprocessing. Please note that it is the responsibility of each provider to use the correct procedure codes and modifiers to ensure payment at temporarily increased reimbursement rates. Attached below is the DHCF listing of both the billing codes and new rates for skilled nursing services and the temporarily enhanced reimbursement rates.
