| RE: | Requirement to add the Vaccine Booster Shot Status to DDA Database for People Supported by DDA |

The Department on Disability Services (DDS), Developmental Disabilities Administration (DDA), releases this transmittal to reissue the guidance on the requirement for DDA providers to upload the vaccine booster shot information for the people they support into the DDS database. This transmittal updates **DDS Transmittal 21-08: Requirement to enter COVID-19 Vaccine Booster Shot Status into MCIS for People Supported by DDA**. Providers should document relevant vaccine booster shot information into the DDA database for all the people supported by DDA who have received the 1st and 2nd dose of corona virus vaccine. Per the CDC recommendation, adults 18 or older should receive the vaccine booster shot; 5 months after the second dose was administered for people who received the Pfizer; 6 months after the second dose was administered for people who received the Johnson and Johnson vaccine. (COVID-19 Vaccine Booster Shots | CDC) In addition, providers should continuously update vaccination and/or vaccine booster shot information for each person supported within 48 hours of vaccination. Provided below is the vaccine booster shot detail data as of January 12, 2022.

| Vaccine type | Eligible | booster completed | % completed |
|-------------------|----------|-------------------|-------------|
| Johnson & Johnson | 90 | 4 | 4.44% |
| Pfizer | 327 | 44 | 13.46% |
| Moderna | 1342 | 140 | 10.43% |
| Total | 1759 | 188 | 10.69% |



There are several walk-up vaccination sites throughout the District of Columbia for people to receive the vaccine booster shot, no appointment required. (Get Vaccinated | coronavirus (dc.gov)

The corona virus vaccination and/or vaccine booster shot status for each person should be updated in the DDS database by COB, Friday, January 20, 2022. Failure to comply with the provision of this transmittal shall result in the issuance of DDA provider sanctions against provider agencies.

The following information details the process for uploading vaccine booster shot information into the DDS database.

People who are eligible to receive the vaccine booster shot are listed on the provider's dashboard.
