### Review of May 1, 2018, Minutes

No substantive changes made to the minutes.

#### **SPCD** response to PCR Annual Service Coordination Review

Winslow Woodland, Deputy Director of DDA, presented SPCD's response to the PCR Annual Service Coordination Review. Overall, SPCD thanked PCR for its report and made a note of many of the areas that have seen increases in performance including person-centered documentation, health-related action taken by service coordinators, and incident reporting for people living in natural home settings. SPCD made a note of key metrics that have seen decreased performance. The Deputy discussed SPCD's changes to ensure that LON's are committed at the Pre-ISP meeting to ensure that LON's are committed before the ISP meetings; the challenge that exists in consistently recording Silver Alert and Voter Registration because these activities are usually done once and may not transfer to each iteration of the ISP; and addressing the inconsistent completion of ISP amendments. The Deputy assured that SPCD continues to work on improving these and other areas that require further development.

SPCD and PCR further discussed the overall quality of notes, which because of a decrease in performance, continues to be a problem. A suggestion that PCR, SPCD, and QRU should consider collaborating on creating a tool to gauge the quality of notes and consistently look at the issue through monitoring tools. Winslow made note that a meeting with IT would also be necessary to work out logistics to avoid duplication of issues. The committee congratulates SPCD on its 99% overall customer satisfaction rating.

#### **GUCCHD Introduction on Falls from SRI Data**

GUCCHD informed the committee of their upcoming study on consumer-related falls reported via incident reports. The study will look at 71 falls which were reported between March and May of this year. Preliminary information reveals that 50 of those falls were reported as reportable incidents, and 20 falls required medical attention. GUCCHD made note that many of the incidents were classified as "other," which presented a challenge gathering the data. According to GUCCHD, the study will be presented at the August or September QIC meeting.
