spending more than 25% of what the current agreement is, we will have to do a new solicitation. The new solicitation is not competing out that service; it is establishing the qualification of the Entity to provide those services. We're not opening it up for bids, so that anyone can get those funds, it is establishing qualifications so the CIL can receive those funds that were identified for that purpose. The solicitation documents were given to Mr. Simms and Ms. Debbie Berhan for completion. The SILC and the CIL need to decide what these funds are to be used for.

Mr. Ariza-Silva felt that Mr. Reese's explanation gave clarity on how the funds will be allocated once the solicitation document is completed. The questions was asked how long would it take for the CIL to receive the funds. This question was directed to Mr. Saivosh, and his reply was 1-3 weeks, which seemed reasonable.

It was explained that RSA would be posting the solicitation on their website, and then agencies could submit their qualification to become a Human Care Provider

If RSA continues to be our Designated State Entity funds will be allocated as they are now. Dahlia will fill out the paperwork and the approval to pay the invoice.

The challenge we run into is the Resource Plan, which pays Dahlia's salary, as well as, all the expenses of the SILC. If the SILC had a way to receive these funds and expend them, RSA could transfer those funds over to whichever entity would perform those functions on behalf of the SILC. This does not change RSA's responsibility to make sure the funds are being spent appropriately. It was established that even if there is an independent active SCIL, RSA still has the responsibility to monitor the funds that are received from the Feds. It also has the

obligation to monitor the services that are provided with the funds. The SILC has the same obligations.

Mr. Ariza-Silva spoke with Mrs. Marlene Jones-Kinney from Quality Control, RSA to discuss with the CIL regarding the development of the peer groups.
