RE: Appendix K Rates - Living Wage Increase Effective July 1, 2022, Retainer

Payments for Day Services Ended Effective January 1, 2022 and Retroactive Supporting Living and Residential Habilitation Rates Effective October 1, 2021

and January 1, 2022

The Department on Disability Services (DDS), Developmental Disabilities Administration (DDA), releases this updated transmittal to provide Appendix K Payment and Reimbursement Rates based on the Department of Employment Services living wage increase from \$15.50 per hour to \$16.10 per hour for all workers. Reimbursement rates are adjusted to reflect the change to the Living Wage Act of 2006, effective June 8, 2006 (D.C. Law 16-118; D.C. Official Code § 2-220.01 et seq. (2012 Repl.). The enhanced rate includes the fifteen percent (15%) increase for Direct Support Professionals (DSPs), LPNs and RNs. Providers shall pay their DSP's the new rate effective July 1, 2022. Retainer payments for day services ended effective January 1, 2022, and changes to the Personal Care Services modifier code are also reflected. Appendix K temporary enhanced and quarantined rates are retroactive effective October 1, 2021 to December 31, 2021 and January 1, 2022 to June 30, 2022 for Supported Living and Residential Habilitation services are also reflected in this transmittal.
